## PASTOR'S REPORT

Dear brothers and sisters in Christ,

That salutation sounds so formal. Yet it reminds us of the bond we hold in common. We are not gathered around an ideology, a party, a flag, or some charismatic leader. We are gathered in the name of Jesus, who calls us to be part of one great, blessed family.

Our sanctuary stands in downtown Newark, a testament to both its antiquity and its centrality. It is a beautiful building – a witness to the glory of God and the importance of its purpose, and we have worked hard to maintain and preserve it. Over the past year we have patched holes in the roof, repaired leaks and the damage caused to the ceiling and organ workings; we have driven out the bats (hopefully!), and are renovating our sign – all to ensure that St. Paul's endures into the future.

But does the future need us? Decades of nationwide church decline make it clear our purpose and value is no longer simply assumed. Our society is making it clear it is no longer certain why or whether it needs us, its trust eroded by incessant disputes, scandals, and the politicization of Christianity.

2025 was one of the most tumultuous in our country's history, and 2026 is likely to be even worse. Political corruption, a widening economic disparity, the erosion of economic safety nets and the gutting of national relief organizations are pushing more people into poverty. We see the effects around us in the form of increased homelessness and requests for aid from those who have been laid off or simply find it impossible to keep up with the rising cost of living.

Last year we continued offering monthly community meals during the warmer months. Perhaps these need to be continued year-round? This year we are exploring whether to join with Holy Trinity Lutheran in expanding our ministry to the homeless, sick, and hungry in our community. The need is rapidly growing – and St. Paul's stands in the middle of it all, a monument to the one who insisted that we see, value, and respond to these ones in need, reminding us that they too are our brothers and sisters in Christ.

In the face of such need, the church rediscovers its purpose. I believe that 2026, for all its challenges, will offer us great opportunities to grow deeper in faith and renew our sense of purpose. The Spirit is alive in our congregation, and I look forward to discovering with you its purpose and guidance for us all.

## **PRESIDENT'S REPORT:**

The most notable event at St. Paul's this year was the visit from our sister congregation of St. Bartholomew's in Wittenburg, Germany. Ten people visited, several coming to America for the first time. And although there were some translation issues to address, we shared the languages of worship, music, nature, history, food, and new experiences for them like attending a minor league baseball game. Thanks to Kerrill Foster and Fred Freytag for coordinating the visit and to all the host families and others who helped make it such an eventful week.

2025 also brought a continuation of the community picnics we started in 2024. That year, we held three picnics. This year, we expanded to five picnics - from June to October - with growing attendance by neighbors and community members as well. Plus, thanks to Thrivent support, the direct cash outlay for burgers, hot dogs, buns and ice cream was fully funded.

With the completion of the church directory (available where you grab your weekly bulletin), we now have a handy way to contact each other, look up those familiar faces to which you just can't place the name, and just as importantly, add notes in the back as new folks join us for services.

Speaking of service, the proposed involvement in ministry to the homeless remains a proposal. While council will continue to arrange opportunities for questions to be asked and answered, particularly by those who have been most involved in providing those services at Holy Trinity, there have been no commitments or decisions. We look forward to working with the congregation to determine how best to answer God's call on this topic.

Finally, some notes about volunteers. I am very grateful to Greta Blegvad and Mary Billy for their now-completed service on the council, Julie Hippen and Beth Warner for joining the council, and Sally Fink for re-joining the council. As you have questions or comments, please reach out to the pastor or any of us on the council.

Still, most volunteers don't come with terms of office, choir seasons, or formal committees. You are the ones who bring a dish to a potluck, make coffee, clean tables, set the altar linens, light the luminaries, serve as ushers, shovel the snow, read the scripture, send a get well greeting, sing along with the hymns, contribute to the mitten tree or rummage sale, offer a ride, welcome a newcomer, or help take down the Christmas decorations. ## **PROPERTY COMMITTEE:**

We were fortunate not to have any major repairs needed this year. At one point there was water coming through the ceiling in the choir transept, but it was determined to be through an old unused blower in the tower. We are scheduling Durable Slate Co. to finish stone and mortar repairs in 2026 and will remove the blower apparatus at that time.

Because we finally feel that the problem of leakage around the bell tower is finally solved, we arranged for paint and plaster repair in several areas of the sanctuary. This was very satisfactorily completed before Easter.

It was necessary to find someone new to care for the lawns and courtyard as

well as snow removal. We are very happy that member Sam Hippen was willing to take on this job. Parking lot snow removal continues to be the responsibility of Phoenix School which rents parking spaces during the school year.

This spring we renewed our contract with Phoenix School/Licking County Board of Education for their use of our parking lot. Because of increased costs and usage the rent was raised to \$4,917/year.

After many years we finally renovated the main restrooms in the education building. We are grateful to Tim O'Keefe who organized and carried out the project. The cost was covered by WELCA.

A generous member arranged for serious bat abatement work to be done in our buildings. All detectable entry points were sealed over a period of time to allow existing bats to leave and prevent new residents. Time will tell how effective this was but we are hopeful.

Greta has been arranging for the renovation of St. Paul's sign on the corner of the sanctuary. It was worn, weathered, and damaged during the construction of the round-a-bout. What is currently there is temporary until the newly built interior is completed. It will look much the same as the classic old one, but with far better lighting.

We continue to be thankful for the generous work of Hank and Tammy Trites in maintaining the plantings around the buildings and for the attractive seasonal plantings around the entrance. The Fallers have kept our buildings presentable and are always willing to address specific areas when asked.

## **RENTAL PROPERTY COMMITTEE:**

All of the Church Rental Properties are currently rented. After a generous donation, we now have eight properties. The value of these properties is over one million dollars. As of February 1, 2025, the committee hired Encore Real Estate Services to manage these properties.

We welcomed two new tenants during the year which required additional property maintenance including cleaning, interior and exterior painting, roof repair, tree cutting and driveway access. A wheelchair ramp was also constructed at the 28<sup>th</sup> Street property for Wayne and Margaret Marx through a government grant program.

The gross income from these properties, before expenses, was \$97,468.70 in 2025. Rental income of \$33,000.00 was added to the Operating Fund during 2025.

A special mention and thank you to our committee members; Dick Daly, Dan Fischer, Don Grube, Gerald DePalmo, Mike Campbell and Kerrill Foster.
